
## Washtenaw County Road Commission

## **RIGHT OF WAY DEDICATION DRAWING AND DESCRIPTION STANDARDS**

## Effective March 8, 2018

- 1. Submit Legal Description and Sketch on legal size paper (8 1/2" x 14")
- 2. Provide a minimum of one half (1/2") inch margin on each sheet, with a two and one half inch (2 1/2") margin at the top of each sheet.
- 3. White durable paper with black, non-fading ink.
- 4. Label all Drawing and Description sheets "Attachment A" at the top of the sheet.
- 5. Signed and sealed by the Michigan Professional Surveyor preparing the document.
- 6. Not necessary to certify survey, but if not, state "This document is not a P.A. 132 Survey".
- 7. Boundary Lines
  - a. If entire parcel is not shown, state so.
  - b. Right of Way Acquisition Area to encompass existing statutory right of way. Hatch existing right of way different from proposed additional right of way.
  - c. Describe right of way from centerline (usually the section line) of road out to the proposed additional right of way line.
  - d. All right of way lines shown and described by bearings and distances.
  - e. Boundary (Right of way) lines are connected to two Public Land Survey corners when situated on or parallel with a section line.
  - f. Boundary (Right of way) lines connected to one Public Land Survey corner when not situated on or parallel with a section line.
  - g. Intermediate traverse line is shown when a boundary line is adjacent to a body of water or water course. Distance is shown from the traverse line to the water's edge.
  - h. If Curved boundary lines are not tangent to the forward/back tangent lines, state so.
  - i. Curved boundary lines show:
    - i. Central Angle
    - ii. Length of arc
    - iii. Degree of Curvature
    - iv. Long Chord Bearing and distance
- 8. North Arrow shown
- 9. Scale not greater than 1 inch = 500 feet.
- 10. Drawn to scale.
- 11. Graphical scale shown.
- 12. Width of existing highways, streets, alleys and easements shown.
- 13. Names of Roads.
- 14. Names of Subdivision or Site Condominium.
- 15. Basis of Bearings.
- 16. Area legend/table showing
  - a. Existing Right of Way, Acres and Square feet
  - b. Additional Right of Way, Acres and Square feet

- c. Total Right of way Acres and Square feet
- 17. Tax Parcel Identification Number of Parcel donating Right of Way.
- 18. Legal description of parcel donating Right of Way
- 19. Source of legal description of parcel donating Right of Way
- 20. Public Land Survey Corners Shown.
- 21. Reference Corner shown, (if applicable).
- 22. Date of Drawing
- 23. Date of and revisions.
- 24. Name and Address of company preparing drawing.
- 25. Legal description caption includes section, township, county, state.
- 26. Legal description using bearings and distances around the boundary of the right of way acquisition area.
- 27. Legal description bearings and distances match the bearings and distances on the right of way drawing.
- 28. Legal description containing existing, proposed additional, and total right of way areas in acres and square feet.
