WHEREAS, WCRC acknowledges that WCPARC has agreed to own, operate, maintain, and repair the Border-to-Border Trail Segment D2 Phase 1 in accordance with the Agreement for the Project; and

WHEREAS, WCRC recognizes that, as an Act 51 Agency, it is required by the Federal Highway Administration and MDOT to be the recipient of such TAP grant funds for the Project on behalf of WCPARC.

# **STAFF REPORT – 6-25 to 7-8-18**

# Jim Harmon, Director of Operations

- Jim Harmon provided a project update sheet.
- Wiard Boulevard (Superior Township) this project includes milling, repaving, ADA ramps and drainage improvements. The first course of asphalt was applied yesterday and the road will be topped tomorrow.
- Limestone resurfacing is ongoing throughout the county.
- Webster Church Road (Webster Township) limestone resurfacing is complete, Valentine Road (Webster Township) will be complete today.
- Brookville Road from Curtis Road to Pontiac Trail (Salem Township) crews are performing tree trimming and prep work for limestone resurfacing.
- Henzie Road culvert (Manchester Township) This project began on July 11 and the culvert is scheduled to be installed this afternoon. This project is being done with assistance from Lenawee County.
- Van Tuyle Road culvert (Manchester Township) construction on a box culvert will begin shortly.
- Platt Road culvert north of Stony Creek (York Township) this project will begin shortly.

# Matt MacDonell, Director of Engineering

- Harris Road reconstruction project (Ypsilanti Township) WCRC flew a drone to video this project in process. This project is anticipated to be complete by mid-August
- Platt Road/Textile Road (Pittsfield Township) culvert is being installed. Textile Road is closed for reconstruction.
- Baker Road Intersections (Scio Township) this project is moving forward. Underground work is still in process and the earthwork is beginning.
- N. Territorial Road box culvert (Northfield, Salem Townships) is being installed. There was a slight delay with gas main utilities which has caused about a week delay with this road being closed.
- The Preventative Maintenance Contract is underway.
- Bemis & Moon Road Roundabout Project (Pittsfield, York Townships) is out for bid.
- Zeeb Road reconstruction project (Lod Township) bids have been advertised.
