- The 2017 state trunkline audit has started. Staff set up a SharePoint site to enable the Road Commission and the State of Michigan to more efficiently exchange information.

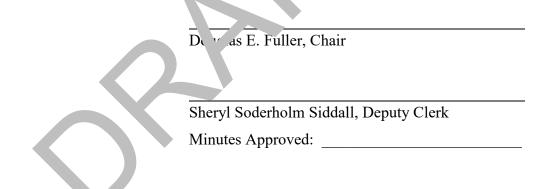

Commissioner Doug Fuller opened the Working Session at approximately 9:00 a.m.

### Boland Corridor Quit Claim Deed (Dexter-Chelsea Road) - A. Philbrick

Sheryl Siddall provided a review of the Boland Corridor Quit Clair. Need issue. County Parks is moving ahead on this non-motorized path project from Freer Road to Linia Center Road. Not many outstanding issues or questions from City of Chelsea and residents along the corridor. The piece along Dexter-Chelsea Road east of Lima Center Road has not begun yet. The Road Commission has received letters from residents to quit claim this property to the property residents. The Philbrick provided a background and history on the Boland Corridor and stated not all properties that provided letters are the eastern portion of Chelsea. Mr. Philbrick stated there needs to be consideration if there would be futured by the Road Commission for this easterly portion of the Boland Corridor. ### SAW Grant Presentation Aubbel, 1 th & Clark)

Sheryl Siddall stated that the pad Cormission applied for a SAW grant in 2013. The Road Commission was recently awarded a \$1.2 m. For collar SAW Grant for Asset Management for storm water systems throughout the county. Karen Stickel and Jim Miller provided a presentation of the awarded SAW grant.

### PA 202 Application for Waiver and Plan (Pension & OPEB)

Dan Ackerman, Director of Finance & IT provided a background on PA 202. Last year the legislation made retiree healthcare and pensions a priority. Mr. Ackerman stated that we are required within six months of fiscal year end to file an initial financial report. We had until the end of June to submit initial forms which we did. Mr. Ackerman has communicated with MERS regarding this. Mr. Ackerman provided a review of the requirements of where the Road Commission funding stands for Pension & OPEB. Currently the Road Commission is underfunded for the Pension. We are considered underfunded because we are not categorized as a primary unit of government. We have submitted an application for waiver and plan for the pension & OPEB outlining the steps the Road Commission has taken towards being fully funded for the Pension & OPEB.

### **Miscellaneous Discussion Items**

Commissioner Doug Fuller reported that he observed the West Willow area yesterday. Traffic at US 12 is traveling at excessively high rates of speed with another fatality on July 16<sup>th</sup>. Sheryl Siddall stated that she has had extensive conversations with MDOT on how to improve the safety in this area. The Road Commission will continue to work with MDOT to try to improve the safety in the West Willow area. A meeting with MDOT will be scheduled within the next 30 days.

County Commissioner Ruth Ann Jamnick stated her concerns at the intersection of exiting onto US 12.

## **PROJECT ANNOUNCEMENT**

# Chubb Road and Five Mile Road Paving December 7, 2018

The Washtenaw County Road Commission (WCRC), in partnership with Salem Township, is excited to announce a reconstruction project planned for the 2019 construction season on Five Mile Road from Chubb Road to Napier Road and on Chubb Road from Five Mile Road to Six Mile Road in Salem Township.

What will the improvement look like? WCRC, in partnership with Salem Township, will pave these sections of unpaved local roads. Once completed, the roads will become county designated routes (All-Season Roads) to better accommodate the commercial trucking that already exists along these corridors. Utilities will be relocated in advance of construction. Tree removal will also be conducted to achieve required grading and roadside drainage.

How is this project being funded? This is a township-initiated project based on the needs and desires identified by the surrounding community. Both roads are located within the township's Industrial District and are used daily by heavy industrial trucks. This project is funded by Salem Township and the business owners along the corridors.

When will this project be completed? To comply with environmental regulations protecting the Indiana Bat and the Northern Long-Eared Bats, tree removal will begin sometime after January and be completed before March 31, 2019. Utility relocation is expected to take place in the spring of 2019 as well.

Construction is expected to take place during the summer of 2019. It is estimated WCRC and its contractor will take four to five months to complete the project. Detour routes will be in effect to construct each roadway.

**How can I get more information?** Staff from WCRC will be presenting project details at the January 8, 2019, Salem Township Board of Trustees Meeting at Salem Township Hall. This meeting is open to the public.

### A. CONSENTITEMS

### 1. Salem Township Right of Way Agreement - Chubb Road/Five Mile Road

Chubb Road between Five and Six Mile Roads, and Five Mile Road between Chubb Road and 1,800 feet west of Napier Road are local, gravel roads located in Salem Township. Salem Township approached the Road Commission with the desire to convert these roads to paved all-season roadways due to high volumes of commercial truck traffic and to eliminate dust issues. WCRC entered into an agreement with Salem Township in September of 2016, where the Township agreed to pay Bergmann Associates for preliminary engineering services and WCRC administration costs associated with the all-season roadway design. ROW needs have been identified for construction. Staff is ready to acquire these needs on behalf of the Township. This agreement will secure reimbursement from Salem Township to pay for ROW expenditures. The estimate to pave Chubb and Five Mile Roads is \$3.8 million.

PROPOSED MOTION: that upon the recommendation of the Director of Engineer and the concurrence of the Managing Director/County Highway Engineer, the Board hereby approves an agreement with Salem Township for Salem Township to pay for all right of way acquisition costs associated with paving Chubb Road between Five Mile and Six Mile Roads, and Five Mile Road from Chubb Road to Napier Road.

### 2. Elimination of Redundant Policy – HR-19 (Loss of Drivers License)

To assure that the Washtenaw County Road Commission continues to have an up-to-date database of applicable organizational policy's, the Human Resources Manager is proposing to eliminate the following policy because it is addressed in the updated Drug Free Workplace policy.

### 3. Drug-Free Workplace Policy

## 4. <u>2019 Capital Equipment Purchase Authorization – 2020 International HV613 Truck</u> Chassis

Staff is requesting the Board authorize the purchase of a new 2020 model year International HV613 truck chassis from Tri-County International Trucks, Inc. of Jackson, Michigan using the State of Michigan MIDEAL purchasing program (MIDEAL Contract # 071B6600122). In accordance with the attached quotation from Tri-County International dated November 29, 2018, for a total cost of \$111,363.00. Component upfitting will be presented for Board approval separately also using the State of Michigan MIDEAL Purchasing Program. The proposed equipment purchase is funded in the 2019 Capital Equipment budget.

PROPOSED MOTION: that upon the recommendation of the Director of Operations and the concurrence of the Managing Director, the Board hereby approves the purchase from Tri-County International Trucks, Inc., 3001 E. High Street, Jackson, Michigan, 49203 through the State of Michigan MIDEAL purchasing program of one new model year 2020 International HV613 truck chassis for the total cost of \$111,363.00.

### 5. 2019 Capital Equipment Purchase Authorization - Wheel Loader

Staff is requesting the Board authorize the purchase of a new 2019 Caterpillar 950M HL Wheel Loader from Michigan CAT using the State of Michigan MIDeal purchasing program (MIDeal Contract #071B7700084). This purchase will be assigned to District 3 at the Chelsea Yard. Purchase of the new loader includes the trade-in of an aged wheel loader, #844, 2003 Komatsu WA380-5L, 5,940 hours, S/N A52171, presently assigned to District 4 at the Manchester Yard. The District 3 current loader, #843, will be reassigned to District 4. Please reference attached quotation 140566-03 from Michigan CAT dated December 3, 2018 for the new wheel loader with accessories of \$289,672.00, less trade-in value in the amount of \$40,000. The final out-of-pocket purchase equals \$249,672.00. Purchase includes Caterpillar standard and extended warranties and guaranteed buybacks of 5 years/maximum 4,000 hours at \$160,000 or 10 years/maximum 6,000 hours at \$125,000. The proposed equipment purchase is funded in the 2019 Capital Equipment budget.

PROPOSED MOTION: that upon the recommendation of the Director of Operations and the concurrence of the Managing Director, the Board hereby approves the purchase from Michigan CAT of a new 2019 Caterpillar 950M HL Wheel Loader for the net cost after trade-in of \$249,672.00 through the State of Michigan MIDeal purchasing program.

### 8. 2019 Managed Services Provider (MSP) – Dominant Systems Corporation

Staff has worked with Dominant Systems Corporation (DSC) for several years in various capacities. Their role expanded in 2018 and they have taken an active role in several recommended initiatives. These initiatives are substantially complete and have moved the organization's infrastructure, software, hardware and security protections forward.

Halfway through 2018, the Road Commission hired a System Administrator to provide an internal presence. This individual has learned from DSC and is familiar with nearly all aspects of the Road Commission's hardware and software. The System Administrator's institutional knowledge will allow the agency to transition Dominant's role to a Managed Services Provider relationship. There are so many complex systems and technology is changing at a rapid pace, making it a necessity to have a MSP working in conjunction with internal staff. Dominant will be able to proactively monitor all systems on a daily basis and assist staff with anticipating any problems.

PROPOSED MOTION: that upon the recommendation of the Director of Finance and IT and the concurrence of the Managing Director, the Board hereby approves a Managed Services Provider contract for 2019 with Dominant Systems for a not to exceed amount of \$120,000.00.

This Agreement ("Agreement"), is entered into as of the \_\_\_\_ day of \_\_\_\_\_\_, 2018, by and between by the Board of County Road Commissioners of the County of Washtenaw, a public body corporate, with offices at 555 Zeeb Road, Ann Arbor, Michigan 48103 ("WCRC") and Salem Township, a public body corporate, with offices at 9600 Six Mile Road, Salem, MI 48175 (the "TOWNSHIP").

WHEREAS, The Township desires for Chubb Road between Five Mile Road and Six Mile Road, and Five Mile Road between Chubb Road and Napier Road, to be paved roadways (the "PROJECT"), and

IT IS NOW THEREFORE AGREED, the Township will be responsible for all costs associated with right-of-way purchases ("**ROW**") to construct the Project, however, all offers for ROW acquisition will first be presented to the Township for approval and

IT IS FURTHER AGREED, during ROW negotiations, the WCRC shall provide the following to the Township Supervisor: (1) ROW updates as needed; (2) Individual ROW offers made to property owners to secure property for the project, and

IT IS FURTHER AGREED that WCRC will oversee the Project and project will proceed in accordance with current Federal Highway Administration and Michigan Department of Transportation practices and procedures for purchasing ROW. WCRC will coordinate the preparation of ROW documents and secure the required easements or ROW and grading permits for the Project, and

IT IS FURTHER AGREED that WCRC will periodically issue invoices to the Township for payment of Project costs associated with the purchase of ROW that exceed the funds submitted by the Township for the paving of Chubb Road and Five Mile. WCRC shall provide documentation to the Township of all costs incurred for the ROW, and

IT IS FURTHER AGREED that the Township shall make payment within thirty (30) days of receipt of invoices issued by WCRC as described herein. The Township will be responsible for any and all actual costs to purchase ROW and secure grading permits, including WCRC and/or consulting staff time to secure ROW.

### INTENT

To provide accommodations to employees who lose their driving licenses because of drug or alcohol use if employees agree to participate in the Drug Free Workplace Program.

### **PURPOSE**

If an employee loses his or her required driver's license due to the use of controlled substances or alcohol, and the employee agrees to participate in the employer's Drug Free Workplace Program, he or she will be permitted to remain in his or her current position for a minimum of thirty (30) days. After the 30 days, he or she will be permitted to fill a temporary position for a period of up to twelve (12) months or until he or she obtains a valid driver's license, whichever comes first. The grade of the position will be based on the job responsibilities which the employee is capable of performing. At the end of twelve (12) months a review of his or her job performance will be made to determine what further action needs to be taken. These provisions do not protect an employee due to layoff, involuntary transfer or demotion caused by a reduction in the workforce.

### INTENT

It is the intent of the Washtenaw County Board of Road Commissioners to provide a safe, healthy and productive work environment for all Washtenaw County Road Commission (WCRC) employees. Consistent with this commitment and in accordance with the Federal Drug Free Workplace Act the manufacturing, unauthorized use or possession, sale or distribution of illegal drugs/alcohol by WCRC employees while on duty or on Road Commission property is strictly prohibited.

### **PROHIBITIONS**

- A. Alcohol concentration. No employee shall report for duty or remain on duty requiring performance of safety-sensitive functions while having an alcohol concentration of 0.02 or greater.
- B. Possession of Alcohol or a Prohibited Substance. No employee shall be on duty or operate a commercial motor vehicle while the employee possesses alcohol or a prohibited substance.
- C. On-duty use. No employee shall use alcohol or a prohibited substance while on duty.
- D. Pre-duty use. No employee shall perform safety-sensitive functions within four hours after using alcohol or while under the influence of a prohibited substance.
- E. Use following an accident. No employee required to take a post-accident test shall use alcohol for eight hours following the accident, or until he/she undergoes a post-accident alcohol test, whichever occurs first.
- F. Refusal to submit to a required alcohol or controlled substances test. No employee shall refuse to submit to an alcohol or controlled substances test required under this policy.

### **TESTING CONDITIONS**

A. Pre-Employment – All approved applicants for employment with the Road Commission shall be given a blood and/or urine test for prohibited substances coincidental with a pre-employment physical. Those testing positive shall not be

hired.

- B. Reasonable Suspicion An employee of the Road Commission may be ordered to submit to testing upon reasonable suspicion that such an employee may be under the influence of alcohol or prohibited substances while working or while at the workplace.
- C. Post-Accident Any employee involved, while operating equipment, in a reportable accident. A "reportable accident" means an accident:
  - 1) involving the loss of human life;
  - 2) resulting in bodily injury to a person who, as a result of the injury, immediately receives medical treatment away from the scene of the accident, and/or the employee receives a citation within 8 hours of the accident, or;
  - 3) one or more of the motor vehicles incurs disabling damage as a result of the accident, requiring the vehicle to be transported away from the scene by tow truck or other vehicle, and/or the employee receives a citation within 8 hours of the accident.
- D. Return to Duty/Follow-Up Any employee participating in an approved substance abuse evaluation drug and alcohol program as described in Section VI shall be tested at such intervals as recommended by the Substance Abuse Professional. The employee is responsible for the cost of this testing.
- E. Random Employees in designated positions that require a Commercial Driver's License (CDL) will be subject the random selection process.

### **TESTING REQUIREMENTS**

A. All breath, blood and/or urine examinations will be performed by a certified testing facility recognized under the U.S. Department of Transportation's current rules and which is accessible through the Employer's current designated medical facility.

- B. Samples testing positive for one of the designated controlled substances under the U.S. Department of Transportation's guidelines shall be subjected to an additional confirmatory gas chromatography mass spectrometry (GC/MS) test. No urine test shall be reported positive until confirmation by such GC/MS testing. In addition, the laboratory shall retain a portion of the initial sample to be made available on request for independent confirmatory tests at the employee's expense.
- C. Collection and processing procedures for the types of test covered by this policy shall be done substantially in accordance with those procedures in 49 CFR Part 40 to ensure that samples are not tampered with during or after collection.

The confirmatory positive test result "cut-off" levels shall be as provided in 49 CFR 40.87(a) and as set out in the following table:

- D. Only specimens confirmed as positive by the GC/MS test procedure shall be reported as positive for controlled substances by the testing laboratory. Test results shall be reported to the Medical Review Officer substantially in accordance with the procedures set out in 49 CFR 40.97. The Medical Review Officer shall review the results reported from the laboratory substantially in accordance with the procedures set out in 49 CFR 40.127 through 40.151.
- E. Tests for alcohol levels shall be considered to verify that the employee is under the influence when the blood/alcohol level meets, or exceeds, .02%. Any employee who provides a positive alcohol test result of .02% or greater, but less than .04%, shall be mandated to wait a minimum of twenty-four (24) hours prior to again reporting for duty.
- F. Before reporting test results to the Road Commission, the Medical Review Officer shall ascertain from records made available, and from the employee during the interview, whether an employee who has tested positive for a controlled substance is, or has been, taking prescription or nonprescription medication prior to furnishing the test sample. The Medical Review Officer shall make the decision as to whether such medications used prior to collection of the test sample render a positive result unreliable. If the employee claims that a medication has been prescribed, and a positive test result is reported to the

Medical Review Officer, the Medical Review Officer shall require that employee to furnish evidence such medication was, in fact, prescribed for the employee. Such evidence shall include a copy of a prescription written by a licensed physician or other documentation, such as a notation in an employee's medical records, indicating such a medication was prescribed. The Medical Review Officer shall not consider prescription medicine taken without a prescription as an excuse in determining whether or not a test result should be attributed as positive.

### **ACTIONS**

A. Alcohol test results. A screening test of less than 0.02 will be considered "negative" and the employee may return to work. In the event a test registers 0.02 or greater, the employee will be required to take a confirming test. If the confirming test registers less than 0.02, the test will be considered negative and the employee may return to work.

If the confirming test registers 0.02 or greater but less than 0.04, the employee may return to non-safety-sensitive jobs within twenty-four hours following the time of the confirming test. He/she will not be eligible for emergency call-in or scheduled overtime during that period. [If this situation (having a positive confirming test of 0.02 or greater) occurs more than once in any twelve-month period, Section IV of this "Drug-free Workplace Policy" will be implemented.]

If the employee tests 0.04 or greater on the confirming test, then Section VI of this "Drug-free Workplace Policy" will be implemented. Even if the Substance Abuse Professional clears the employee for return to work, he/she cannot return to a safety-sensitive job for twenty-four hours from the time of the positive test, nor will he/she be eligible for emergency call-in or scheduled overtime during that period. In order to return to work, the employee must provide a test from a certified Breath Alcohol Technician (BAT) proving less than 0.02 alcohol concentration within four hours of the time of their return to the job.

- B. Drug test results. Employees receiving a positive drug screen report from the Medical Review Officer will be removed from the job and Section VI of this "Drugfree Workplace Policy" will be implemented
- C. Costs. Employees must bear the cost of any follow-up or return to work tests after a positive result has been given.

### SUBSTANCE ABUSE EVALUATION

A. In the event that testing shall reveal the presence of either alcohol or prohibited substance in such employee's breath, blood and/or urine at the time of testing beyond the accepted levels, that employee shall be required to submit to an immediate evaluation by an approved Substance Abuse Professional for possible alcohol and/or substance abuse problems. Pending such evaluation, the employee shall be placed on immediate suspension without pay. After the evaluation such employee shall be required, as a condition of continued

employment, to enter and participate in such treatment programs as shall be recommended by the Substance Abuse Professional and shall be placed upon medical leave of absence, without pay, except to the extent that such employee shall use accumulated sick time or vacation time during such medical leave of absence.

- B. Once the Substance Abuse Professional certifies that the employee does not present a risk to others in the work place and may return to work, the employee shall be allowed to return to work, subject to the disciplinary provisions of this policy, provided that employee passes a return-to-duty test and can fulfill the requirements of the job. Thereafter, such employee shall be subject to regular drug and alcohol testing at such intervals as shall be recommended by the Substance Abuse Professional. The employee is responsible for the cost of return-to-duty and follow-up testing.
- C. Any employee who shall fail to participate in and/or successfully complete a treatment program, including recommended after-care, as shall be recommended by the Substance Abuse Professional or shall thereafter test positive, shall be subject to immediate discharge.

### SELF-REFERRAL FOR TREATMENT

- A. The Road Commission recognizes that an employee who is unfit for duty due to drug or alcohol abuse is a safety risk to themselves, their fellow employees and the motoring public. To this end, the Road Commission seeks to deter substance abuse through the implementation of this Policy. However, the Road Commission encourages its employees, who may have substance abuse problems, to voluntarily refer themselves to treatment programs. Said self-referral must occur prior to selection for testing or identification of a positive result.
- B. Employees are encouraged to seek treatment for drug or alcohol abuse and are offered cooperation and assistance under this Policy and/or applicable Contract benefits. Additionally, an employee who initiates his/her own treatment shall be exempt from the penalties of this Policy and/or the Collective Bargaining Agreement, subject to the terms and conditions set forth herein.
- C. In order to be exempt, the employee's self-referral must occur prior to any Road Commission-initiated random or reasonable cause testing and/or any other contract violations. The Self-Referral declaration by an employee at the time of random or reasonable cause testing or other contract violation occurrences shall not be allowed as an exemption from the implementation of discipline under this Policy or the Collective Bargaining Agreement.
- D. An employee who has referred himself for treatment shall be required to successfully complete a substance abuse rehabilitation program that includes a return to work drug and alcohol test prior to his return to work. In the event an employee tests negative, he will be allowed to return to work. If he tests positive, the employee must successfully complete a Road Commission-approved

substance abuse rehabilitation program including execution of a medical information waiver which gives the rehabilitation provider(s) the authorization to share confidential medical information so that the Road Commission can monitor the employee's progress in the treatment program.

### REQUIRED NOTIFICATIONS

- A. Convictions and Loss of Driving Privileges. Employees shall notify their immediate supervisor within five (5) working days of any criminal drug statute conviction. Employees involved in equipment or vehicle operations shall notify their immediate supervisor within five (5) working days of any traffic violation conviction involving drugs or alcohol. Each employee who has a driver's license suspended, revoked, or cancelled, or who is disqualified from operating a motor vehicle for any period, shall notify the Road Commission of such suspension, revocation, cancellation or disqualification before the end of the business day following the day the employee received notice of the suspension, revocation, cancellation, or disqualification, but, in any event, prior to operating any Road Commission vehicle or equipment. Failure to do so will result in disciplinary action, up to and including termination from employment.
- B. Prescription and Non-Prescription Medicine. Any employee using a medication which his/her physician has advised the employee the use of such medication may affect the employee's ability to safely operate a motor vehicle, or the employee's ability to otherwise perform the duties of his/her position, shall promptly notify the Road Commission that he/she is currently using such medication.
- C. Fitness for Duty/Call-in. It shall be the policy of the Road Commission that any employees called to report for duty, during emergency or unscheduled operations, shall be personally asked and shall personally respond to the Road Commission's questions regarding their fitness for duty with respect to the consumption of drugs and/or alcohol. Further, the employee shall be required to notify the Road Commission's representative if at any time the employee is not fit to perform his/her duties for the Road Commission in a safe manner as such fitness may relate to the consumption of drugs and/or alcohol.

### **VIOLATIONS**

In addition to any penalties mandated by the Department of Transportation, if an employee tests positive for illegal drugs and/or prohibited substances, or is under the influence (0.04% or above) of alcohol, the following are disciplinary steps that shall be taken:

1) First Offense – Five (5) day suspension without pay; upon completion of the five (5) day suspension and before an employee is allowed to return to work, he/she will submit to an evaluation by a Substance Abuse Professional and to a drug/alcohol test at the employee's expense. Upon approval of the Substance Abuse Professional and a negative test result, the employee will be allowed to

return to work.

2) Second Offense – Discharge.

### **DEFINITIONS**

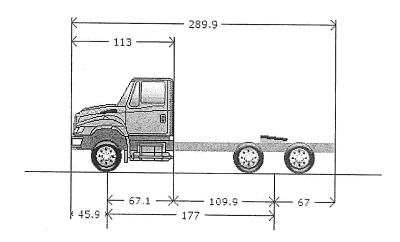
- A. **Under the influence** An employee has been affected by a drug or alcohol, or a combination, in a manner that demonstrates a disregard for life or property or impairs the employee's ability to perform a given job or assignment. Symptoms of being under the influence of drugs or alcohol include, but are not restricted to, misbehavior, obvious impairment of physical or mental ability, slurred speech or difficulty in maintaining balance. Supervisors recommending testing of an employee for being under the influence shall document, in writing, their observations and the information they have which causes them to believe the employee is under the influence before the employee is sent to the appropriate place for testing.
- B. **Prohibited Substance** Any drug or substance that is identified in 21 CFR 1308.11 Schedule I, any non-Schedule I drug or substance that is identified in the other Schedules in 21 CFR Part 1308 except when the use is pursuant to the instructions of a licensed medical practitioner who is familiar with the employee's medical history and has advised the employee that the substance will not adversely affect the employee's ability to safely operate a vehicle or equipment, or any drug or substance which has not been legally obtained
- C. **Drug Testing** Any urine/blood or breath test conducted for the purpose of detecting the presence of a chemical substance in an individual.
