Bunton Road Closure

Mr. Pete Hafler, August Township Supervisor, addressed the Board regarding the Bunton Road Closure. Mr. Hafler stated that there is citizen concern with emergency responders having access with Bunton Road closed. Mr. Hafler is asking the Board to consider steel plates be installed over the closed culvert to temporarily open the road. Mr. Hafler also stated that he feels more priority should be put on much needed road maintenance before funding construction of roundabouts.

Bemis Road Closure

Mr. Ronald Raab addressed the Board regarding the Bemis Road Bridge closure and the Austin Road Culvert weight restriction. Mr. Raab suggested reopening the Bemis Road Bridge with a 3 ton weight restriction and stated that the bridge has been used with a 5-ton weight restriction for five years.

Bunton Road - Drainage

Mr. Jack Lauderman addressed the board regarding a Church next to his property that has a drain that is causing flooding issues on his property. Mr. Lauderman stated that he is concerned about a hole next to Bunton Road adjacent to a cross road culvert.

WHEREAS, it appears to this Board that said petition and application is signed by the owners of more than 51% of the lineal frontage of lands outside the corporate limits of any city of village fronting or touching upon said portion of county roads proposed to be improved; and

WHEREAS, said petition and application is accompanied by a description of the land owned by each signer fronting or touching on said portion of county roads proposed to be improved, and by a certification of the County Treasurer showing what taxes or special assessments, if any, against said lands appear delinquent on his/her books; and

WHEREAS, it appears to this Board that said petition and application complies with the requirements of Act 246 of the Public Acts of 1931, as amended; and

WHEREAS, this Board has examined the location of said portion of county roads proposed to be improved;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Road Commissioners of Washtenaw County, that:

- 1. Said petition and application are hereby accepted.
- 2. This Board hereby tentatively deems the proposed improvements necessary.
- 3. Staff is hereby directed to cause a survey to be made, and to establish grades and make specifications of the kind of improvements suitable for the purpose set forth in said petition and application, and estimates of the cost thereof, together with a plat of the proposed improvements, and file the same with this Board with all convenient speed.

Road Commissioner's Report

Commissioner Barb Fuller attended the Dexter Forum on December 19, 2015 and January 2, 2016. There was discussion on the Dan Hoey/Baker Road project.

Commissioner Bill McFarlane asked if the Road Commission can purchase detour signs versus renting them. Roy Townsend responded that we have purchased these signs in the past but there were incidences of the signs being vandalized and stolen. Mr. Townsend also stated that the cost of these signs is about \$300 dollars, so it makes more economical sense to just rent the signs for a short period of time. The rental company replaces any damaged or stolen signs.

Commissioner Bill McFarlane asked if the crews could perform boom mowing now in the winter months being much less disruptive than in the summer months. Jim Harmon, Director of Operations, responded that last year the Road Commission did a large amount of winter mowing and spent a considerable amount of money on contract mowing services last summer.

Mr. Harmon stated he has already received a call from our mowing contractor interested in providing mowing services for the Road Commission for the upcoming 2016 summer season. Mr. Harmon stated that crews will be out performing winter boom mowing.

Commissioner Doug Fuller attended a MCRCSIP meeting last Tuesday. Two candidates were interviewed for the position of Director of Claims Department for MCRCSIP.

MANAGING DIRECTOR'S REPORT

STAFF REPORT OF 12-7-15 to 12-27-15

Roy Townsend stated that staff is preparing for a very busy 2016 construction season. There will be a meeting held on January 28, 2016 with all township supervisors to provide information on the closed culverts and bridges along with potential funding options within Washtenaw County.
