MANAGING DIRECTOR'S REPORT

<u>STAFF REPORT – 4/11/16 thru 4/24/16</u>

Operations Report – Jim Harmon, Director of Operations

- Jim Harmon provided an update on various road projects.
- PA 283 work has begun starting with Parker Road and Zeeb Road with final paving today.
- The paving contractor will be at Pontiac Trail between Warren Road and Dixboro Road next Monday for paving and two failed crossroad culverts are being replaced.
- The Chip Seal program should be complete by the 4th of July holiday and much of the PA 283 paving will be completed by the 4th of July holiday also.
- Bunton Road culvert temporary repairs are taking place to reopen the road. The steel road plates were delivered last week and will be installed tomorrow. Cadillac Asphalt will pave over the plates. There will be 40 ton load limit signs installed. Bunton Road is scheduled to reopen by the end of this week under a 40 ton weight limit.
- Cold patch production was performed today, producing another 425 tons to sustain the Road Commission through the summer months.

Engineering Report – Sheryl Siddall, Director of Engineering

- The McGregor Road & Wiard Road bridges are ahead of schedule.
- There are three projects for the April letting Countywide Guardrail, Willis Road and the Traffic Signal Backplate project.
- Paving for Prospect Street and Huron Street is in letting for this Friday
- Cadillac Asphalt will perform carryover paving on Old U.S. 12 from M52 to Freer Rd.
- The Ann Arbor/Saline and Textile intersection and Textile Road resurfacing and preventative maintenance are in the June letting.
- The bid opening for the Lone Oak SAD project is June 1st.

Michigan Transportation Fund Receipts (MTF)

Roy Townsend, Managing Director, reported that the March MTF check was up 8% from last year. Mr. Townsend stated that auto sales continue to drive the increase in MTF.

County Wide Millage Initiative

Roy Townsend, Managing Director, reported that the City of Saline and the City of Ann Arbor just passed a Resolution of Support for the County Wide Millage.

Lone Oak SAD – Update

Roy Townsend, Managing Director, reported that a counter-petition was received for the Lone Oak SAD project which was less than 50%. This project will be moving forward taking bids and will come back to the Board for approval. June 1^{st} is the bid opening for this project.
