CITIZEN PARTICIPATION

Barbara Palkoski – Jennings Road Condition

Ms. Palkoski addressed the Board regarding road maintenance on Jennings Road stating that Independence Lake Park located on Jennings Road is the Largest County Park in Washtenaw County generating increased traffic volumes on Jennings Road. Ms. Palkoski stated that there is also a nature preserve being established on Jennings Road which will bring more traffic. Ms. Palkoski asked why there is not a regular road maintenance schedule for Jennings Road and emphasized that something needs to be done to better maintain Jennings Road for the citizens that live on this road and due to the increased traffic volumes generated from the Park and Nature Preserve.

Kathy Van Buren - Weber Road Bridge Closure

Ms. Van Buren stated that she has attended several Board Meetings regarding the Weber Road Bridge Closure. Ms. Van Buren stated that the detour signs at this location have not been replaced. Ms. Van Buren was also requesting the barriers for the bridge closure be replaced with reflective barriers to make them more visible at the bottom of the hill. Ms. Van Buren spoke with Jan Godek, Lodi Township Supervisor, who stated that the township approved their 50% of the funding within 30 days of the closure and Lodi Township was waiting for proposed costs from the Road Commission. Ms. Van Buren stated that they would like the Weber Road Bridge reopened before the next school year begins and are waiting for a construction time line from the Road Commission.

<u>Abandonment Request – Unimproved Portions of Collegewood, Maulbetsch and Roosevelt, Fairview Heights No. 1 Ypsilanti Township</u>

WHEREAS, this Board has received a petition from seven (7) freeholders of the Township of Ypsilanti, Washtenaw County, Michigan praying for the absolute abandonment and discontinuance of the unimproved portions of Collegewood Drive, Maulbetsch Avenue and Roosevelt Boulevard, between Hewitt Road and Washtenaw Avenue, dedicated in Fairview Heights Number One, located in Section 6 of Ypsilanti Township, Washtenaw County, Michigan, depicted in Attachment "A" and more particularly described as:

All that part of said Collegewood Drive lying adjacent to and Southerly of Lots 309 through 317 inclusive except for the East 27 feet for Hewitt Road (1/2 = 60 feet wide) (platted as Hewett Road)

ALSO

All that part of Roosevelt Boulevard (80 feet wide) lying adjacent to and Northerly of lots 298 through 305 inclusive except for the East 27 feet for said Hewitt Road

ALSO

All that part of said Maulbetsch Avenue lying west of lot 305 and East of the East right of way line of Maulbetsch Avenue adjacent to Lot 317 extended south to the West property line of Lot 305.

WHEREAS, it appears from viewing the premises and hearing the petitioners reasons, that it is in the best interest of the public that the said Public Right of Way of the aforementioned portions of Collegewood Drive, Maulbetsch Avenue and Roosevelt Boulevard, as proposed, be absolutely abandoned.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Road Commissioners of the County of Washtenaw, that the above described portion of Public Right of Way of Collegewood Drive, Maulbetsch Avenue and Roosevelt Boulevard, being under the jurisdiction of the Washtenaw County Road Commission is hereby absolutely abandoned and discontinued as Public Right of Way, excepting and reserving easements for drainage and public utilities of record and/or use, as now occupying said right of way.

BE IT FURTHER RESOLVED that this notice of determination be given by the Clerk to the proper authorities of the Township of Ypsilanti and to the Register of Deeds of Washtenaw County, and the State Department of Transportation.

Mr. Harmon reported that the Operations crew completed the installation of this culvert this morning and the road is reopened to the traveling public.

Michigan Transportation Fund Receipts (MTF)

Roy Townsend, Managing Director, reported that the December MTF was up due to some people registering vehicles early to save on the registration increase that went into effect 2017. The MTF was up 15% and closed out nearly 3% higher for the year.
