The Washtenaw County Road Commission, in accordance with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42 USC 2000d to 2000d-4 and Title 49, Code of Federal Regulations, Department of Federally-assisted programs of the Department of Transportation issued pursuant to such Act, hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of gender, disability, race, color, or national origin in consideration for an award.

GASOLINE

- a. Unleaded gasoline Ethanol E10 to be billed and paid for on metered gallons, and not temperature corrected. All proposals for E10 unleaded gasoline which meet or exceed the specifications will be considered.
- b. Unleaded gasoline must meet requirements: EPA A.S.T.M. specifications in relation to Ethanol E10 unleaded; with minimum $\underline{R+M}$ index of 87.0 Octane.
 - c. Gasoline to be shipped by transport or tank wagon F.O.B. to Washtenaw County Road Commission locations. All fuel deliveries must have bill of lading or meter printouts showing actual number of gallons dropped at point of delivery. Tank level readings will be manually done by the driver before and after delivery and noted on the delivery receipt. A copy of the rack delivery sheet from the terminal shall accompany the delivery receipt.

DIESEL FUEL, ULTRA LOW SULFUR CLEAR

- a. Diesel fuel to be billed and paid for on metered gallons and not temperature corrected. All proposals for diesel fuel must meet or exceed the following specifications:
 - 1. Ultra Low Sulfur over the road #2 Clear.
 - 2. Must not contain any bio-diesel.
 - 3. Must meet EPA ASTM Cetane rating of 40 minimum.
 - b. Fuel to be shipped by transport or tank wagon F.O.B. to Washtenaw County Road Commission locations. All fuel deliveries must have bill of lading or meter printouts showing actual number of gallons dropped at point of delivery. Tank level readings will be manually done by the driver before and after delivery and noted on delivery receipt. A copy of the rack delivery sheet from the terminal shall accompany the delivery receipt.

WINTER ADDIVITVE FOR DIESEL FUEL

A winter diesel fuel additive may be requested to be added to the fuel delivery during the winter months on a load by load basis for operation in cold weather. This additional amount will be added to each gallon of diesel fuel delivered during cold weather months as requested by WCRC. Time period may vary, but typically November through March.

Suppliers are required to bid a set price per gallon for winter additives in their bid and list the name of the product being supplied. The product shall contain additives for cetane enhancer, lubricity, anti-gel, de-icer, stabilizers and cleaners.

METHOD FOR BASE PRICING:

The Detroit Market Area OPIS 10:00 a.m. Daily Rack Contract Average will be used as the point of reference in evaluating bid prices. Bids are to be based on a factor above or below the average. Please indicate the factor per gallon which you are quoting. The factor will remain constant during the term of the contract.

Pricing will be based on the day of the order with delivery within 24 hours. Summer delivery hours are M-Th 6:00am-4:00pm. Winter delivery hours are M-F 7:00am-3:00pm.

Bidders may offer to extend the same pricing for up to four (4) additional one (1) year periods, by mutual agreement of both parties after each year. All other terms and conditions must remain the same for any additional periods.

Vendor must be able to deliver gas and diesel in the same transport load and also must be able to split a transport load between locations when necessary. Orders may not always be for a full transport load. The award for gasoline and diesel may be split.

The vendor will provide the required services and will not subcontract or assign the services without the Road Commission's written approval.

Either party may terminate this contract by giving thirty (30) days written notice to the other party.
