MANAGING DIRECTOR'S REPORT

Sheryl Siddall, Managing Director

Staff has continued working to educate the community on the millage efforts. Sheryl made a presentation on the Roads and Non-Motorized Millage to the Saline City County last night. The second and final virtual public meeting on the Roads and Non-motorized Millage will be on July 14th.

The Road Commission has reopened our lobby by appointment only effective July 6, 2020. We have pick up and drop off options available and our on line services are also continuing.

ENGINEERING REPORT - Matt MacDonell, Director of Engineering

- Carpenter Road is substantially complete with some rain garden details to finish.
- Textile Road/Woodland Drive in City of Saline this project is underway.
- Pontiac Trail/Seven Mile Road Roundabout this project is also underway.
- Miller Road/Wagner Road Roundabout this project is slightly delayed due to AT&T finishing relocation efforts. Work on this project will begin next Monday.
- County-wide paving work is continuing. Paving on Plymouth Road between US 23 and East Medical Center at U of M is complete. Paving is ongoing for Old US-12 in the City of Chelsea.
- Cavanaugh Lake Road Culvert work will begin tomorrow.

Brent Schlack, Assistant Director of Engineering, provided a presentation on the Federal Local Safety Program.

OPERATIONS REPORT – Jim Harmon, Director of Operations

- Fog Sealing approaching conclusion for the first phase of this program. Crews are currently working on Zeeb Road in front of the Road Commission building today.
- Sealcoat Program Phase 2 & 3 will begin next Monday consisting of approximately 55 miles in the Chelsea and Manchester district.
- Drainage Work is continuing county wide.
- Limestone Resurfacing Program will be completed today.
- Hot Mix Asphalt resurfacing county wide program is continuing.
- State Road resurfacing project between Ellsworth Road and Old State crews are preparing for this project. The Contractor will put out portable changeable message boards the week of July 20th for this project which will begin the end of July continuing into mid-August.
- MDOT State Trunkline maintenance work continues.
- Jim provided his complements to the shop and stock room on all their service and repairs to keep the equipment operational.
- The Buildings & Grounds crew is doing a lot of WCRC property work.
- Jim provided a review of work zone safety after an incident with some of our crew workers. Matt MacDonell, Director of Engineering, stated that when we limit travel to one lane in each direction, the speeds are much slower which creates a lot of congestion. The contractors install a lot of traffic control devices within work project zones.

FINANCE & IT REPORT - Dan Ackerman, Director of Finance & IT

- Michigan Transportation Fund Receipts The May 2020 MTF compared to May 2019 was down 31%. Year to date the MTF is down about 4.5%. MDOT provided some MTF projections by county. Dan is comfortable with our budgeted numbers at this time.
- Public Act 202 All municipalities in the state of Michigan are required to report on their OPEB and pension costs. The state then determines which municipalities are underfunded. Dan provided a review of the OPEB. For the pension, the state of Michigan requires municipalities to be more than 60% funded. We are considered underfunded currently for the State of Michigan for our pension plan and allowed to request a waiver. Dan Ackerman explained the criteria used considering WCRC as a non-primary unit.
- Dan will be meeting with departments to review the Second Quarter Budget.

Commissioner Doug Fuller suggested considering having a two-hour meeting with the Finance Director and the two new commissioners and other commissioners if they want to, to review the process for how WCRC pays bills.
