MANAGING DIRECTOR'S REPORT

Sheryl Siddall, Managing Director

- Sheryl reported that the County Road and Non-Motorized millage renewal passed by over 76%. Sheryl thanked County Commissioners Sue Shink and Ruth Ann Jamnick for allowing this millage to be on the August ballot. Matt MacDonell, Director of Engineering, and Allen Squire, GIS Developer, worked extensively on putting together the County Road and Non-Motorized millage plan. Last fall, Sheryl Siddall, Matt MacDonell, Jim Harmon and Emily Kizer hosted a group of meetings focused at our elected officials on education of the County Road and Non-Motorized millage. Sheryl expressed a thank you to Emily Kizer, Communications Manager, for working with our communication peers on putting in a lot of communication work on the millage. Sheryl stated there was also an advocacy group that worked with the Road Commission staff on the millage. Sheryl stated that we are very pleased with this outcome and four more years of road millage projects.

This will allow us to hold entirely virtually meetings through October 2, 2020. Staff has been investigating options on how to hold board meetings in the future that include both remote and in person participation by commissioners and the public.
- Nicole Peterson, HR Manager, and Sheryl Siddall have been meeting with staff regarding the changeover to Delta Dental as our Dental provider.

ENGINEERING REPORT – Matt MacDonell, Director of Engineering

- Pontiac Trail/7-Mile Road Roundabout is now open
- Textile Road/Woodland Drive Roundabout is now open.
- Dennison Road culvert has been repaired and the road is open to traffic.
- Waters Road paving is complete.
- Cavanaugh Lake Road project is near completion.
- Miller Road/Wagner Road Roundabout work is ongoing.

OPERATIONS REPORT – Jim Harmon, Director of Operations

- State Road is a major project. This is a county millage project in partnership with an
 agreement with Pittsfield township. This project extends from Old State Street to the
 Ellsworth Road roundabout. The widening, milling and paving of the center turn lane
 is nearly complete. The remainder of the resurfacing of State Street will begin soon
 and is expected to be completed in September.
- Willis Road from Bunton Road to Rawsonville Road paving there has been further work to improve the Willis Road/Rawsonville Road intersection with a top course asphalt paving of this entire job.
- Chip Seal program the chip seal program is near completion for the season. Fog seal operations will resume on August 24th.
- There has been 116,000 tons of limestone & gravel applied to Washtenaw County roads. This work should be complete by the end of next week.

FINANCE & IT REPORT - Dan Ackerman, Director of Finance & IT

- Dan stated that he will be attending a webinar today hosted by the Michigan Department of Treasury regarding containing costs on Pensions and OPEB.
- Finance staff is getting ready for the Workers Compensation Audit with the County Road Association Self-Insurance Fund (CRASIF).
- Dan has updated the 2021 and 2022 budget reflecting the County Road millage passing.
