#### INTENT

The Washtenaw County Road Commission (WCRC) has a statutory duty to maintain a county road system that is reasonably safe and convenient for public travel. While carrying out this duty, either through the course of maintenance activities, improving roadside safety or constructing road improvements, sometimes trees must be trimmed or removed by WCRC staff, its contractors, or third parties under permit.

The intent of this policy is to provide guidance to staff making decisions regarding necessary tree removals and trimming while acknowledging the importance of trees to the Washtenaw County community.

## Background

- Right-of-way serves many purposes for road users:
  - Recovery room
  - Sight distance
  - Space for maintenance activities
  - Road drainage
  - Sense of openness for drivers
- It also has many trees!



### Planning and Design

- Staff will attempt to minimize impact when possible
- Tree removal/trimming will be necessary at times



### Removal Criteria

- This policy will apply to trees
   6 inches or greater in diameter
- Trees and brush less than
   6 inches in diameter may be removed at staff discretion



#### Removal Criteria

#### Removal/trimming may be necessary due to:

- Road and drainage improvements
- Crash frequency
- Intersections and railroads
- Curves
- Partner projects (non-motorized)



### Removal Criteria

#### Removal/trimming may be necessary due to:

- Shading
- Fallen trees
- Dead trees
- Potentially hazardous trees



#### Notification

- Per the Community Engagement Policy and Procedure
- Adjacent property owner notification



### Tree Replacement

- Projects
  - When possible, staff may explore options for tree replacement within project area
- Grant opportunities
- Property owners may plant in ROW under permit



### Third-Party Tree Work

 Permit holders will be made aware of policy and expected to comply where possible


