2025 SCIO TOWNSHIP AGREEMENT

AMENDED

THIS AGREEMENT, made and entered into this 16 day of 2025, by and between the Township Board of Scio Township ("Scio Township"), Washtenaw County, and the Board of Washtenaw County Road Commissioners ("WCRC").

WHEREAS, in December 2023, Scio Township and WCRC entered into an agreement for certain improvements to local roads in the Township of Scio; and,

WHEREAS, that agreement committed a certain amount of funding to the improvements; and,

WHEREAS, for reasons beyond the control of Scio Township or WCRC, not all township funding was used; and,

WHEREAS, Scio Township desires to utilize previously allocated funding to supplement the local road program in the Township of Scio, and

WHEREAS, proper authority is provided to the parties of the agreement under the provisions in Act 51 of Public Acts of 1951 as amended; and,

WHEREAS, this agreement is a continuation of the December 2023 agreement for all intents and purposes to utilize available township funds.

IT IS NOW THEREFORE AGREED, the WCRC will accomplish the improvements as specified herein, all in accordance with the standards of the Board of Washtenaw County Road Commissioners,

IT IS FURTHER AGREED, Scio Township shall pay WCRC for the actual project costs incurred for the project and any cost savings realized from this agreement may be allocated toward a subsequent agreement; and

IT IS FURTHER AGREED, the WCRC will submit an invoice to the Township on July 1, 2025, for 50% of the estimated project costs. Following project completion and final accounting of the project costs, WCRC will submit the final invoice for the actual remaining unpaid costs. The final invoice shall provide supporting detail and information, which reasonably identifies the actual project costs incurred by WCRC. The Township agrees to remit payment within 30 days from receipt of WCRC invoices.

Liberty Road, Stags Leap Lane to Parker Road

Work to include drainage improvements, forestry, shaping the existing surface, and the application of 6" of 23A Limestone (C.I.P.) (approximately 8,800 tons) with associated dust control and project restoration.

Work to include drainage improvements, forestry, shaping the existing surface, and the application of 4" of 23A Limestone (C.I.P.) (approximately 1,200 tons) with associated dust control and project restoration.

Township-Wide Limestone

Work to include shaping the existing surface, and the application of 4" of 23A Limestone (C.I.P.) (approximately 2,000 tons) with associated dust control and project restoration. Township Supervisor and WCRC Staff intend to spread material on Maple Road in conjunction with Ann Arbor Township planned township-wide limestone project work. Cost savings generated from project efficiencies from the 2025 Scio Township Agreement will be utilized and will not exceed the original 2025 Scio Township Agreement estimated cost.
